



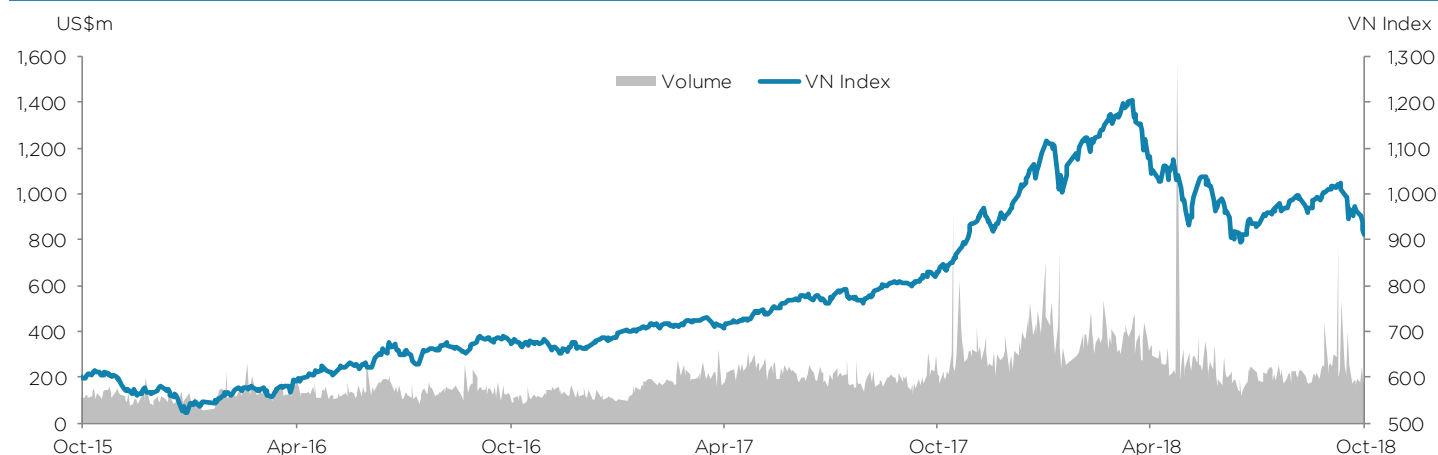

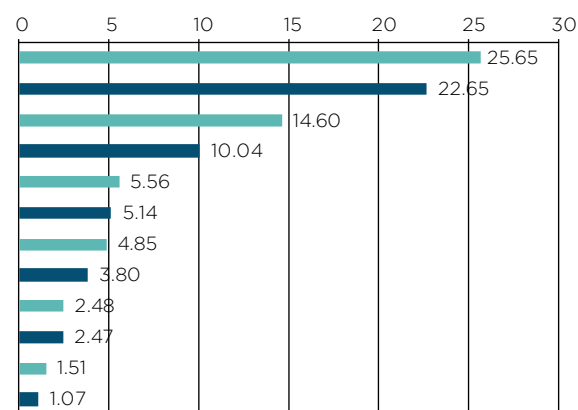

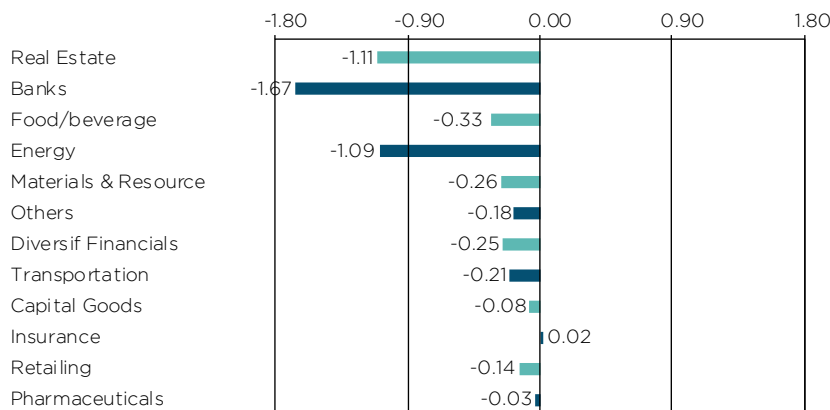
ROLLING 3YR

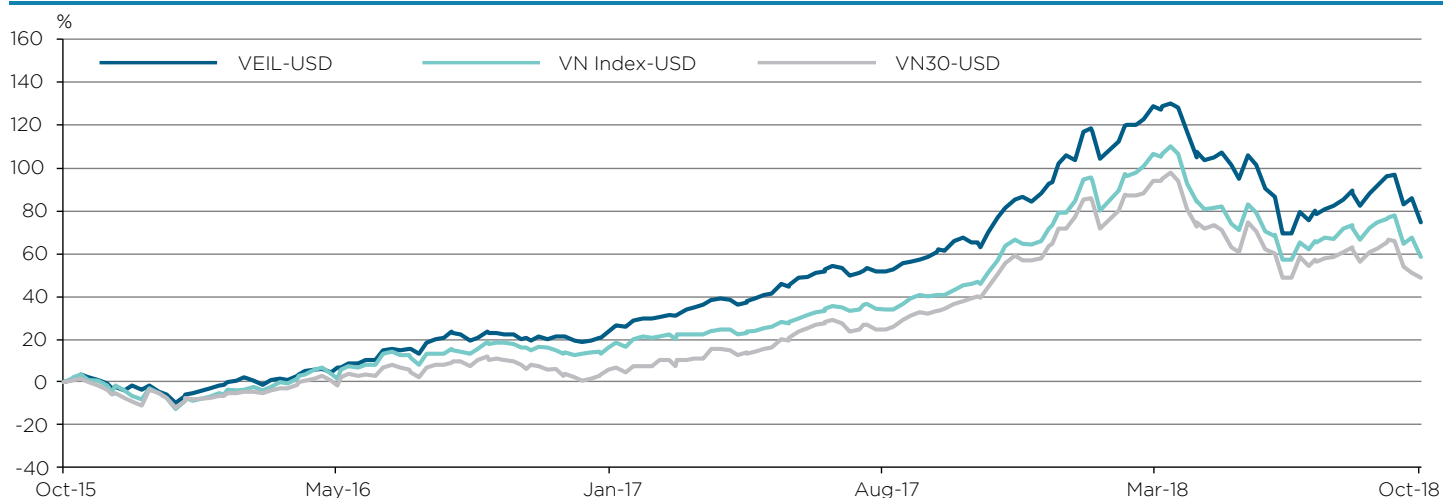
