

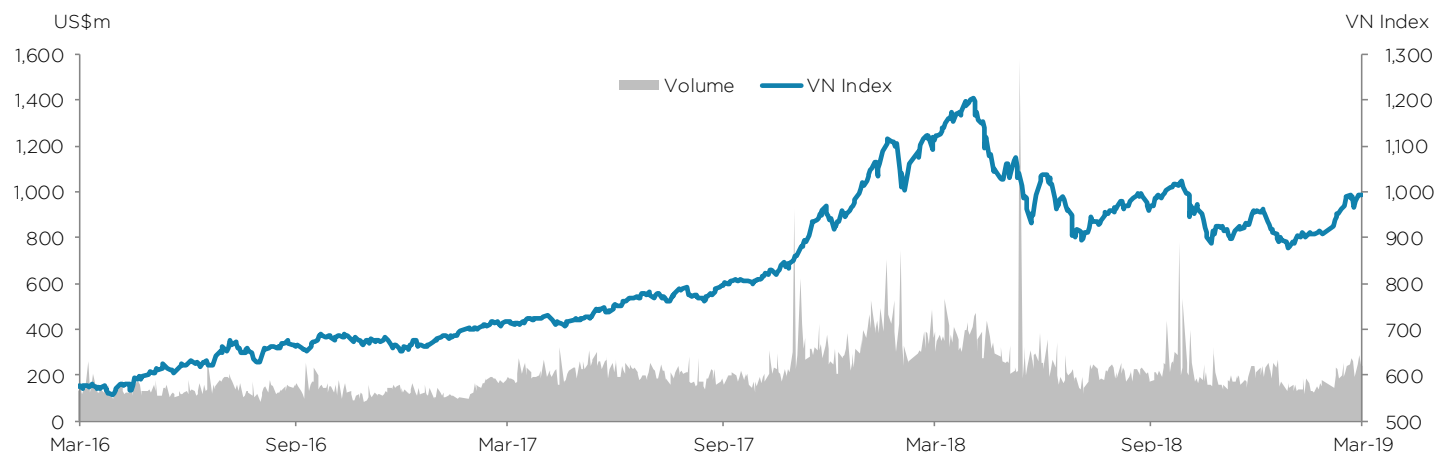

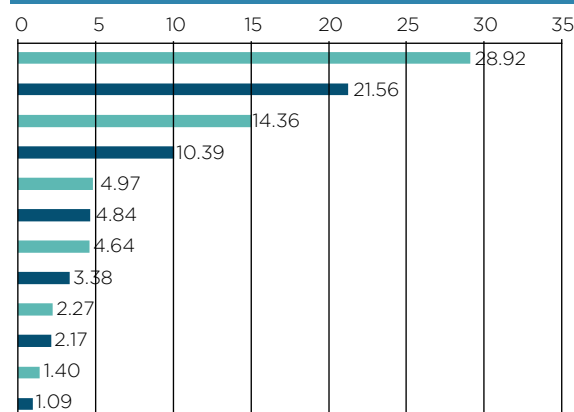

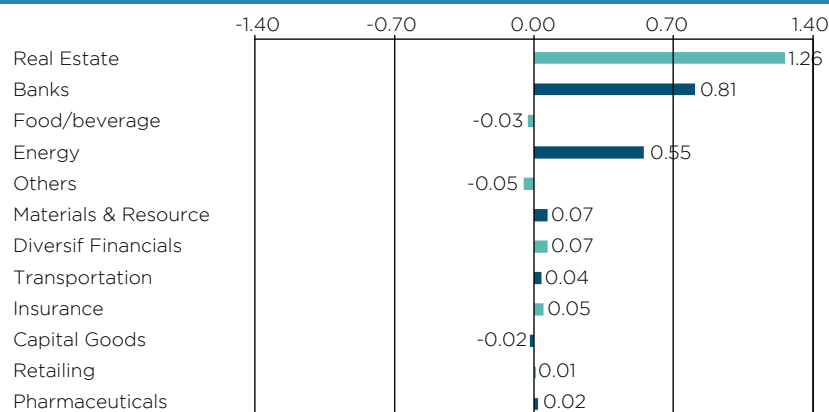
ROLLING 3YR

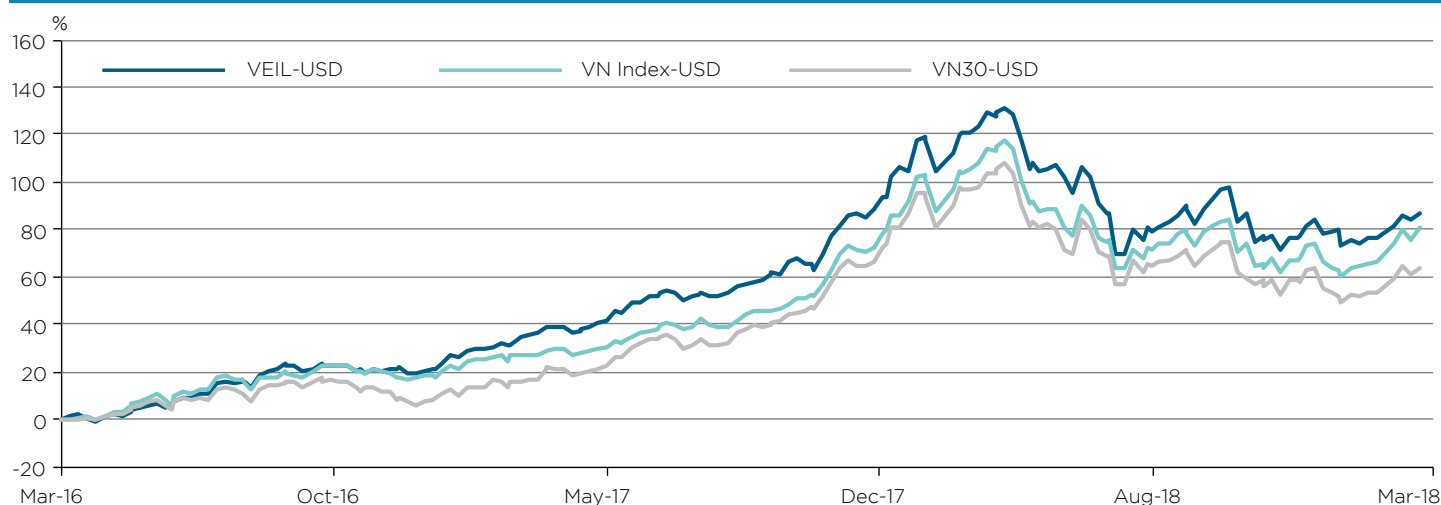
