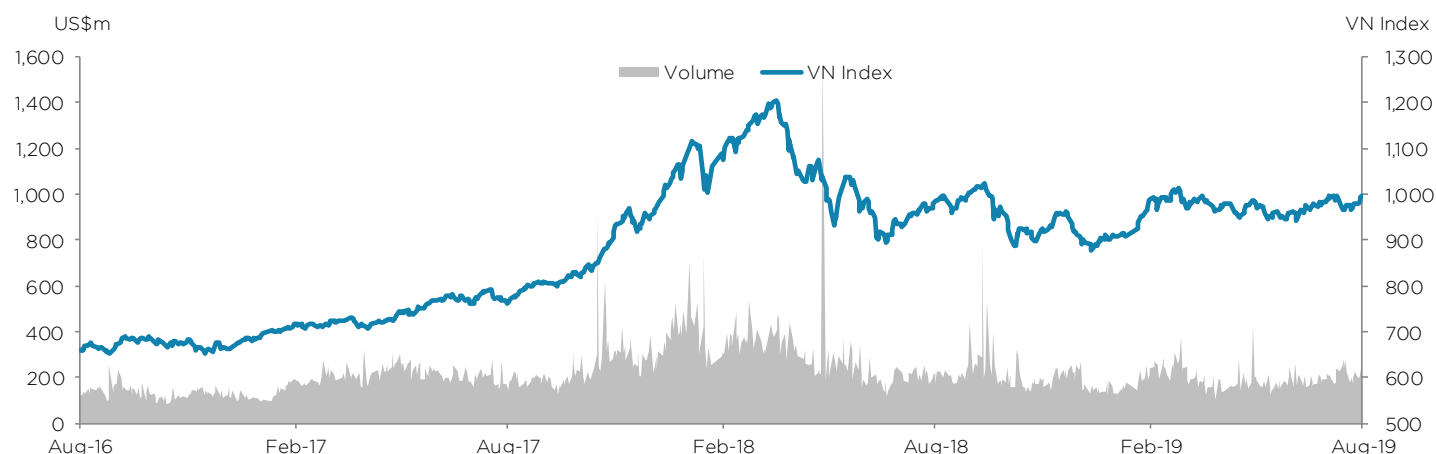

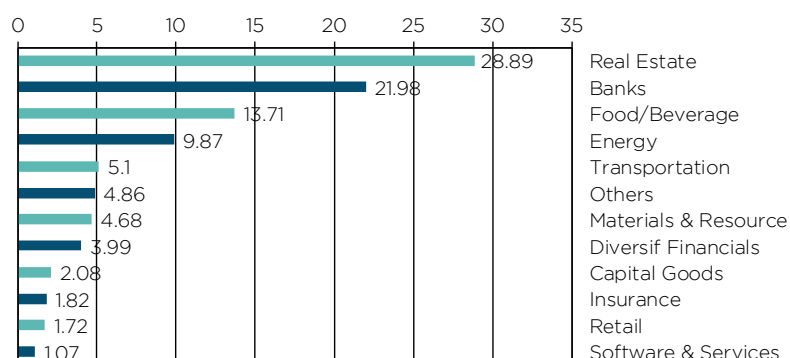

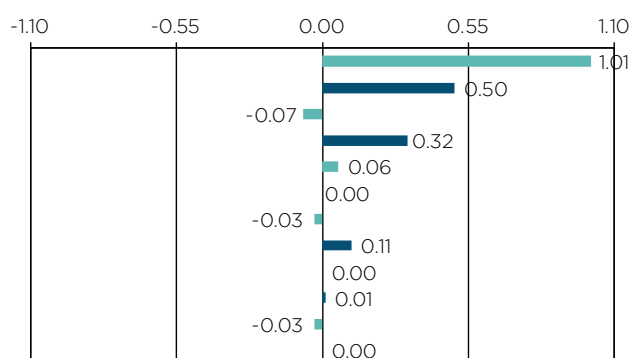
ROLLING 3YR

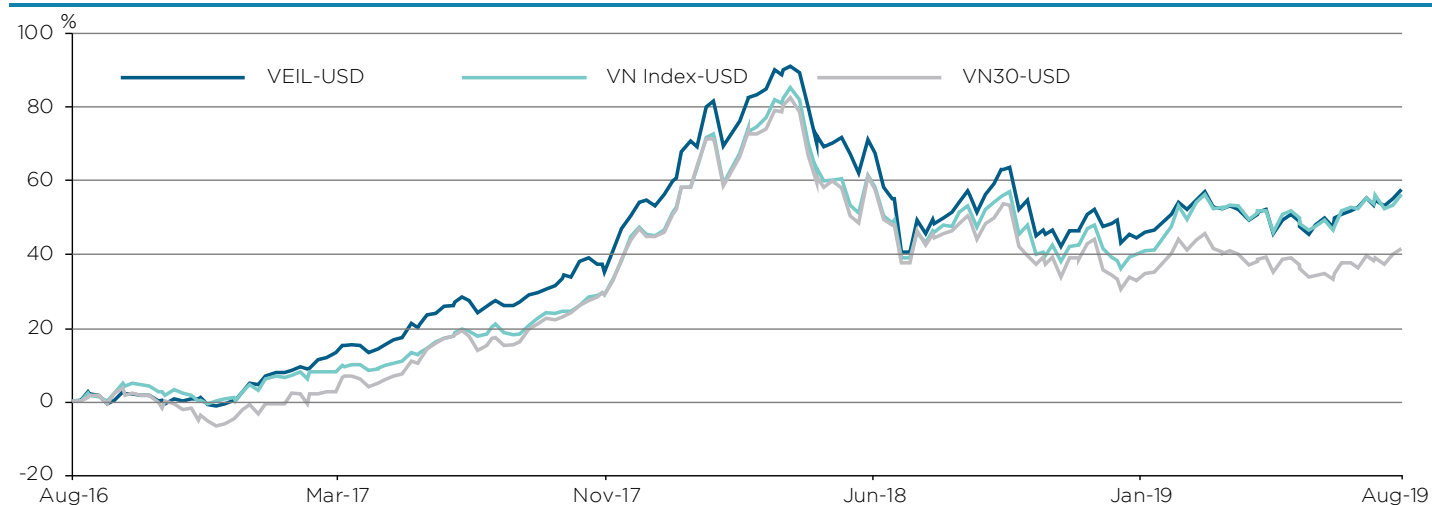
