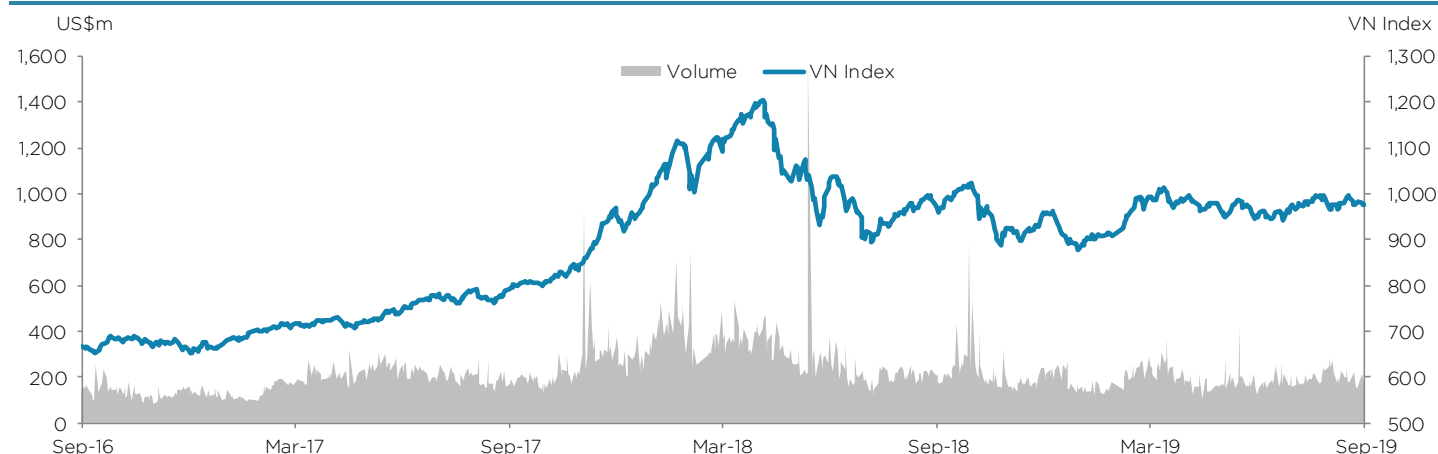

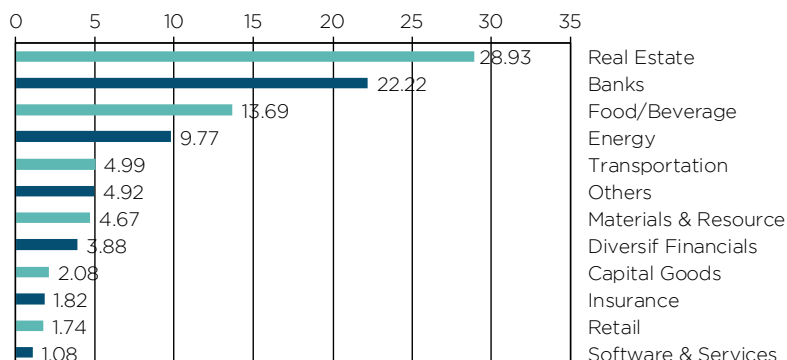

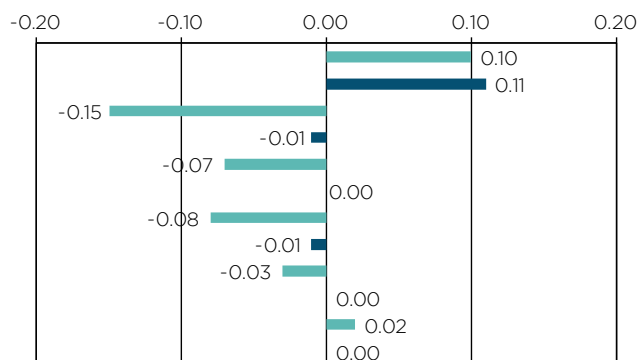
ROLLING 3YR
